We are a European civil society platform, initially launched by the European Commission. Since 2016 ECSPM is an independent organisation of European organisations, networks and research centres in Europe and beyond. Our secretariat is in Copenhagen and we operate under Danish law.

Committed to taking action to preserve the linguistic and cultural resources of Europe and to contribute to the effective management of its linguistic diversity, our members are concerned with the equity and preservation of the official, minority, and heritage languages of Europe, as well as the linguistic and cultural wealth that the inflow of migrants bring to Europe.

A novel and exciting recent development of the ECSPM is the CURUM constituency: a cluster of university units researching issues of linguistic and cultural diversity.

Affiliated with us are partners with significant expertise in school education and lifelong learning, multilingual technologies, and bilingualism studies.

While we continue to problematise the very concept of "multilingualism" and other related notions, we are concerned about language use in today's globalising world, characterised by increasing mobility, where information and knowledge are key determinants for social transformation, protection of the environment, human development, social justice and educational equity.

We view the creative use and synthesis of languages and other modes of communication (i.e., visual, audio, spatial) as important to effective communication, a means to cultural enrichment and to education for the development of plurilingual and pluricultural competences, in educational contexts which increasingly aim at multiliteracies pedagogies so as to enable learners to participate fully in our dynamic, technological and culturally diverse societies. It is our duty to encourage social agents to use creative practices across linguistic and cultural barriers.

With ECSPM on the EU Transparency Register, we are seeking to influence EU decision-making regarding language and language education policies. Our basic tasks, however, are to offer expert advice and assist the implementation of policies valuing European linguistic and cultural diversity, making sure that EU Member States respect language rights, the right of students to learn two languages in addition to the official language of the school and to contribute with research based ideas regarding new paradigms in education.
